It's the Holiday Season: Security Tips

It seems that we busy people are doing more and more of our holiday shopping online with each passing year. For many consumers, the convenience of online shopping sure beats fighting the crowds at the shopping centers. For others, finding a good deal is inspiration enough to jump on the online bandwagon.

Yet this convenience and frugality poses a new problem: the risk of theft from our very doorstep at the hands of dishonest folks cruising the local neighborhoods, who search for the telltale cardboard box left on a porch. Another method of thieves, according to authorities, is to follow delivery trucks and take the newly delivered package within minutes.

A survey from last year by InsuranceQuotes.com revealed that 23 million people said they have had a package stolen from their door. One can only imagine this startling number growing with online shopping becoming more prevalent. Halfway through last year's holiday season, Nextdoor announced a 36-percent rise in conversations about package theft.

So what can be done to protect oneself from this crime? Unfortunately, if you are not home during the daytime and are getting packages delivered, there's no way around the fact that you are taking a risk. However, if you take certain measures, you're not completely out of luck if you become a victim of door-step theft. According to Huffington Post, if you can provide proof that the item was stolen, you can often get your credit card issuer to cover the loss. Hard proof would include security camera footage of the crime. Nowadays, there are more webcam-based security systems on the market that don't cost a fortune. Some of the options are Nest Cam, Piper, Canary, and Perch, according to HuffPost.

A double benefit of the camera is perhaps a deterrent of the theft to begin with, if the camera is prominently displayed. Video footage is also definitely helpful to police if there seems to be a string of related incidents, though that may be little consolation to you after the fact.

Another way to have peace of mind during the holidays is to simply have your packages delivered to your work place, if possible. If that's not an option, you can look into paying for special privileges from shippers like The UPS Store. For example, "Choice Members" and "Premium Members" can have packages sent to UPS stores to safely await your pickup, according to the UPS website. This premium membership costs \$40 per year according to another website.

One of the more interesting newer concepts to prevent theft of packages is a product called Package Guard. This product is essentially a Frisbee-shaped device designed to have packages placed on it by the deliverer. When it detects a package has been placed on it, the Package Guard sends you a notification. Additionally, if it detects the package has been lifted off of the device without authorization, it will sound off a loud alarm. There is debate whether this product would actually keep your packages safe, but it seems to have gotten some traction on the market recently.

Taking some special precautions may seem like a hassle, but it's important to remember that—as safe as we may feel—there are no guarantees that our neighborhood won't be targeted. In fact, SHE has not been immune from this type of theft in the past. Some extra steps could save you some heartache and dollars if you are ever victimized.

As a side note, neighbors looking out for one another can be the best deterrent of crime. So, if you happen to be home during daytime hours, take notice of your neighbors' routines and usual vehicles. Never feel like you're over-reacting by reporting something that seems out of the ordinary. Even a casual mention of something unusual could be related to odd activity that another neighbor noticed, shedding light on some suspicious behavior that should be reported to authorities.
